General Comments A monitoring inspection occurred today. The children were observed during nap/quiet time and outside play in the outdoor classrooms.

Discussed with the Educators in rooms 5, 6A, and 6B the importance of informing parents of incidents that occur with their child(ren) at the end of each day. Parents are to sign these non-reportable incident logs on the day the incidents occur. Documentation of both accidents requiring minor first aid and if I child becomes hurt IE: bit, hit etc by another child must be done on a daily incident log. When documenting a child's behavior this must be done in collaboration with the parent/guardian and completed on a daily incident log and signed daily by the parent.
