<p><b>General Comments</b></p> <p>Some children were in the outdoor play space, while a smaller group of children were heading out to the local library, when licensing staff arrived at the licensed facility to conduct a follow-up monitoring visit.</p> <p>The group of children that stayed back at the licensed centre were engaging in a multiple of play activities outdoors. A few children were making mud cakes using dirt that was dug up in the outdoor play environment and water from the hose. Another group of children were helping their educator rinse off the access ink off the children's towels that they decorated using fabric ink. The children did an amazing job customizing their towels! Another small group of children were flying a kite while playing on the outdoor play space.</p> <p>While licensing staff inspected the outdoor play space, it was noted that there was standing water in the tires. Please ensure you either drill holes in the tires to allow drainage of accumulated water to maintain the safety of the children.</p> <p>While inspecting the indoor play space, licensing staff observed rabbit droppings on the floor outside the small rabbit cage; however, the children did not have access to this area as the operator had the area blocked off by a gate. When the school-aged group went inside just before lunch, the area around the small rabbit cage was cleaned up and free of rabbit droppings. Please ensure that this area is kept free of rabbit droppings at all times in order to maintain the health and safety of the children.</p>

General Comments

For the purposes of section 17 of the Early Childhood Services Act, the requirements with respect to the transportation of children documentation is kept at the centre or in the vehicle while transporting children are as follows:

(a) if the driver of a motor vehicle is a staff member, he or she shall not be included in the child-to-staff ratios calculated under section 9 and 10;

(b) despite paragraph (a), the driver of a motor vehicle who is a staff member is included in the child-to-staff ratios calculated under section 9 and 10 if the children transported are school-aged children and the route taken is between the licensed facility and the school;

(c) the driver of a motor vehicle and the motor vehicle must be in compliance with the Motor Vehicle Act and the regulations under that Act.; and

(d) the motor vehicle must be equipped with:

(i) a record of emergency contacts for each child receiving services at the licensed facility, and

(ii) a first aid kit that is equipped with the contents prescribed by New Brunswick Regulation 2004-130 under the Occupational Health and Safety Act, as a first aid kit that is not a personal, Type P first aid kit.

While licensing staff was still onsite the operator submitted a Change In Service so that in the future, the licensed facility will be permitted to transport children.
