Comments: One staff files are missing the signed statement regarding obligations under the Act and licensing regulation.

Comments: In the 3 to 4 years old classroom, the storage room does not have a doorknob and is not locked. Administrator confirmed that this will be fixed as soon as possible. Meanwhile, the educators will ensure that children do not access that area.

The inspector had a discussion with the administrator regarding the recommended procedures in circumstances where the parents are unable to provide this information.</p> <p>A follow-up inspection will be conducted at a later date in order to verify some elements that were not observed during the inspection and to follow-up on compliances given.</p>
