Comments: Inspector was unable to verify that all eligible educators had completed 10 hours of professional learning hours. Administrator must ensure that proof of completion is on-site and that the eligible educators are completing their hours. The inspector spoke with the educators, and some confirmed that they had not completed any professional learning hours during the year.

Comments: In one of the staff files verified, the duties and responsibilities is missing. The administrator must ensure that all required documents are inserted into the staff file.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (c) staff member records that include (iv) a signed declaration confirming that the staff member has read and understood his or her obligations under the Act and this Regulation.	24(1)(c)(iv)	Mar 12, 2025	
Comments: In one of the staff files verified, the signed statement regarding obligations under the Act and licensing regulation is missing. The administrator must ensure that all required documents are inserted into the staff file.			
31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.	31(3)	Feb 28, 2025	Feb 28, 2025
Comments: While observing the outdoor play area, the Quality Assurance Monitor observed a small amount of waste (medical glove, pieces of wood, broken toys, apple sauce cap). The outdoor play area must be maintained safely and free of hazards. The Quality Assurance monitor asked a staff member to pick up the waste and put it in the garbage. Deficiency is now compliant.

Comments: The Quality Assurance Monitor observed the infant children playing in the same outdoor play area of the preschool children. Infant outdoor play area must be separated or used at a different time then other children. Deficiency is now compliant.

The QAM also observed the children transitioning to the outdoor play area, the children were also observed playing in the outdoor play area. Positive interactions were observed between the educators and the children.</p>
