<p>A renewal inspection occurred on November 22, 2023.</p> <p>The children were observed during morning inside play, morning snack, story time, outside play, lunch and quiet time.</p> <p>Recommending that Inspection reports are posted in the entry way to the 4's and After School program so parents who have children only in this area have access to these reports.</p> <p>Also recommending that the School-Age room have defined interest centers set up. It was observed that this is not occurring in this room.</p> <p>In the 4's room - transitions were smooth, a timer was used, kids were given reminders. I have notes about the Monster trucks and ramps and how the children were engaged. Lots of documentation.</p> <p>Educators in all rooms were observed having positive interactions and speaking kindly and appropriately to the children and redirecting them appropriately.</p>
