<p>General Comments</p> <p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities this afternoon including outdoor play, stories, water play, board games, art, and dramatic play. The preschool children in Room #7 were observed spending extra time outdoors today. Educators adjusted the outdoor play time as the children were engaged, the weather was warm and there was fresh snow on the ground. The preschool children in Room #6 were observed during the transition to outdoor play. Educators encouraged children to get dressed independently and assisted when needed. Transition wait times were eased by educators taking small groups of children outside as they were ready. The school-age children were observed playing board games and exploring homemade playdough made by their educator.</p> <p>Purposeful planning is evident throughout the environments through invitations, documentation and materials added that support the children's current interests (building, superheroes, construction. vehicles, water play and gross motor play). Documentation had been removed from the walls as the facility was preparing to be repainted over the weekend; QA Monitor was still able to observe documentation of the children's learning as the educators had the documentation available.</p> <p>Grilled cheese sandwiches and pickles were served for lunch. Handwashing routines were observed after outdoor play and at arrival from school. Monthly fire drills are documented. Daily attendance records are accurate and reflect all children present. Child-to-staff ratio was observed to be met during Monitoring Inspection. New staff file (1) review was completed, all required documents are in place. Facility is currently meeting the 50% trained Early Childhood Educators (2 out of 4) requirement.</p>
