Comments: During the renewal inspection, the inspector observed that there were no art materials accessible and on low open shelves. The operator must ensure that children have access to art materials and are arranged on low, open shelves. During the inspection, the inspector had a discussion with the operator regarding the intent of having art materials easily accessible.

Comments: The inspector observed a playpen in the play area. The facility must have a designated rest area. A rest area is a location that ensures the peaceful rest of the children. It is a designated zone where no play takes place. The operator must ensure that when children napping during the day, children benefit from a safe, secure, and peaceful environment that respects their personal needs. While on site, the operator brought the playpen into a different room. Deficiency is now compliant.

Comments: The inspector had a discussion with the operator regarding incident records. The operators informs the inspector that she does not document minor incidents and those rarely happens. The inspector referred and showed section 6.5 of the Operator's Manual to the operator. The operator must ensure that all minor incidents are properly recorded, documented and signed by parents so that they are well informed of any incidents that may have involved the child while at the facility.			
50(2) The operator of a licensed facility shall inform the parent or guardian of a child involved in an incident on the day the incident takes place and shall ensure that the parent or guardian signs the daily log to confirm their awareness.	50(2)	Apr 26, 2024	
Comments: The inspector had a discussion with the operator regarding incident records. The operators informs the inspector that she does not document minor incidents and those rarely happens. The inspector referred and showed section 6.5 of the Operator's Manual to the operator. The operator must ensure that all minor incidents are properly recorded, documented and signed by parents so that they are well informed of any incidents that may have involved the child while at the facility.			

General Comments

During the time of the inspection, the inspector observed indoor and outdoor play as well as lunch and the rest period. Inspector observed positive interactions between the Operator and the children, such as getting on their level to play with them and speaking kindly to them. Operator was giving the children positive reinforcement by using words of encouragement while doing a snake craft. The children wanted to carry on with a new craft using the bingo punches from the snake craft, so the operator kindly provided them with new papers to keep going.

The inspector was not able to observe if there is ample shade to protect children from the heat of the sun during the summer months.
