Comments: Inspector found a bottle of bleach in an unlocked upper cabinet in the classroom. All toxic products must be placed under lock and key. Operator placed these under lock and key immediately. Deficiency is now compliant

Comments: Inspector observed that the absence codes are not used consistently on the daily attendance records. Administrator must ensure that the parents advise whether the child's absence is due to illness or another reason and that this information be indicated on the daily attendance records.
