Comments: Infant Outdoor Play Area: Stool within in play area in poor repair. To be removed. Small pink and blue ride-on - handle bars cracked causing a pinch point. To be removed and replaced.

Comments: The outdoor play areas is currently made up of only woodchips. Another surface must be added. Examples: wood platform, pea gravel, turf, sand, pavement, etc.

Comments: Infant & Preschool Outdoor Play Area: Materials depleted. Materials to be added and set up in a way that invites children to explore. Examples of materials to include, but are not limited to balls, pots, pans, utensils, bowls, pylons, small vehicles, plants, art materials, clipboards, rulers, books, loose parts, tools, nets, magnifying glasses, containers (for bug catching/dumping/pouring), water play materials, mark making materials and materials that support the children's current interests.
