<p>General Comments</p> <p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities this morning including dramatic play, music and movement, block play and outdoor play. Each environment is set-up with a variety of materials for children to explore. Materials have been added to the environments that support the current interests of the children. Documentation is posted that supports the children's current interests and learning experiences.</p> <p>QA Monitor left some recommendations on ways to set-up the two-year-old room. QA Monitor recommended dividing the room up more to close of the wide-open empty space in the centre.</p> <p>Hand washing routines observed. Monthly fire drills documented. New staff files (4) reviewed, all required documents in place.</p>
