General Comments

Licensing staff arrived at the licensed facility on July 14th, 2022 at 12:00 pm. A majority of the children were napping when licensing staff arrived at the centre.

Staff files and children files were complete with all required documentation and were very organized.

The centre was very clean and had an abundance of documented learning posted on the walls inside the classroom, as well as, on the walls in the hallways. These are a wonderful examples of the New Brunswick Curriculum Framework For Early Learning and Childcare ~ English. Another wonderful example of the New Brunswick Curriculum Framework For Early Learning and Childcare ~ English, was a group painting activity where the children sprayed paint on a very large piece of brown paper and created a lovely abstract painting creation!! When the operator showed me pictures of the children participating in this activity, it was very evident that fun was had by all children! This painting activity occurred on the morning of the inspection visit.

While observing in the classrooms and outside on the playground, licensing staff noted that all educators were very engaged with the children and the children's play. Positive child guidance, redirection and positive reinforcement, was also observed by the educators.

Licensing staff was inspecting the kitchen area located on the upper level of the licensed facility and noted that a couple of infant bottles were being stored in the refrigerator and not labelled with the intended child's name.

When this was brought to the attention of the operator, the operator labelled the bottles while licensing staff was still on site.

While inspecting the outdoor play space, licensing staff noted the stationary equipment, located on the outdoor play space, was not surrounded by protective surfacing. Please ensure the stationary equipment is surrounded by protective surfacing according to the manufacturer's manual.

During the license renewal inspection visit, licensing staff noted that a child was moved from their classroom and put in another classroom, in order to comply with child-to-staff ratio according to section 8.1- Child-to-staff ratio and supervision. Section 8.1 of the Operator Manual states, "consistency is extremely important and frequent changes of staff and play areas are avoided. The same groups of children are with the same educators each day and are with the same educators each day and are not moved around to meet child-to-staff ratio or maximum group size." It is not best practice to move children from one room to another to meet childto-staff ratio. Please refrain from moving children to meet child-to-staff ratio.
