Comments: This morning's attendance records were not completed. Attendance records are to be completed each time a child arrives and leaves. Attendance records and to be accurate and reflect all children present at any given time.			
31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.	31(3)	May 20, 2022	
Comments: A container of insect killer was observed on the deck. To be locked in an inaccessible storage space. A container of motor oil was observed under the steps. To be locked in an inaccessible storage space. A water table was observed on the deck, containing rain water. Rain water to be drained / emptied, after rainfall. Standing water is not permitted, and new water is to be added to water table, when in use.			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (d) clean and in good repair.	32(1)(d)	May 23, 2022	
Comments: Play kitchen is accumulating dust and debris. To be cleaned. Wooded TV Stand / Shelf - accumulating dust and debris. To be cleaned.			

General Comments
A Monitoring Inspection was completed this morning. Children were finishing up a yoga activity upon arrival. Three children were present today. Operator was engaged with the children – joining in play, prompting ideas, and using positive reinforcement and encouragement. Operator stated that the children are very interested in dramatic play, with the play kitchen and accessories being one of the more popular items right now. Operator also stated that the children have been enjoying arts and crafts, especially painting. During today's inspection, children were observed in the dramatic play area, making food, and collecting payment, playing with Little

## General Comments

People, and playing with puppets. Children were also observed washing their hands before snack, and then sitting at their table, eating their snacks. A conversation was had with operator regarding pre-kindergarten workbooks. Workbooks are not recommended. Documentation – a conversation was had with operator regarding documentation, and the different ways documentation could be increased within the facility. Two trampolines were observed in the outside play area. Operator stated that the trampolines are "out of bounds" and that the children do not play on them. The usage of trampolines is not permitted in ELC-Homes and or Facilities. A climbing dome and a large play structure were observed in the backyard. Operator stated that neither of the structures were used by the children that attended the ELC-Home. Currently, there is no protective surfacing beneath either structure. To be used, both structures would require protective surfacing. A conversation was had with the operator about protective surfacing options (mulch, gravel, shredded rubber). Grass is not appropriate surfacing for these types of structures.
