<p><b>General Comments</b></p> <p>Prior to arrival, the children were outside playing before the rain started. As tomorrow is the last day of school, many of the materials that they use throughout the year have been stored. However, there was enough materials for the children to use.</p> <p>The educator was observed interacting with the children positively, showing interest in conversation and engaging at their level. The educator was observed reading books to the children and kept reading until the children no longer had interest. The educator respected the children and allowed them to have choices over their routine. For example, the children were asked if they wanted to clean up the toys so that they could have lunch. As their response was no, the educator said that they could wait a few minutes. Once the toys were cleaned up, the educators sat with the children and ate lunch with them.</p> <p>Each child had a memory book that included experiences from the past year that they got to take home with</p>

them after graduation. The educators also use artwork, learning stories, and pictures to help document the children's learning experiences.

The children bring their own lunch and snacks but any food that may be provided by the centre is noted in the monthly newsletter that is given to the parent(s). For example, today the children were given ice cream for afternoon snack and the parent(s) were already made aware of it.

The school-age children arrived and were engaged in different activities in the classroom. Invitations for play were set up at the tables and the educators were observed playing card games such as Slamwich with them.

If the corporation directors ever plan to be in ratio with the children, they are also required to have new first aid and CPR certification. If the relief staff returns whose First Aid and CPR certification has expired; it must be renewed prior to covering at the facility again.
