The staff in question showed QA monitor a picture of her certificate. Deficiency is now compliant</p>

All staff member's file must include a copy of a valid certificate and a valid cardiopulmonary resuscitation certificate. Staff was able to show a picture of her certificate. However, it must be printed and inserted in the file.

Comments: Quality Assurance Monitor noticed a storage space with cleaning supplies that was unlocked. Toxic products, chemical products and cleaning supplies must be locked and inaccessible to children. Educator immediately locked the storage space containing the products. Deficiency is now compliant

A monitoring inspection was conducted.</p> <p>During the visit, these elements were verified:</p> <ul style="list-style-type: none"> <li>-ratio</li> <li>-administrative records</li> <li>- staff member's files, qualifications and checks</li> <li>- If all required documents were posted in a visible and prominent place in the facility</li> <li>- storage space for toxic products, medication and children's personal belongings</li> </ul> <p>QA monitor had a discussion with the staff in charge regarding the importance in washing hands before snack. During the visit, indoor play and transition to outdoor play were observed.</p>
