Comments: 1 staff member is missing the certificate of First Aid / CPR. The administrator must ensure there is a copy of First Aid / CPR in the staff's file.

Comments: During the follow-up inspection, the inspector observed the attendance record sheet for preschool class is not documented. The administrator must ensure the attendance record sheet are up to date.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (j) smoke alarm, smoke detector and fire extinguisher inspection and maintenance records.	24(1)(j)	Sep 29, 2023	
Comments: During the follow-up inspection, the inspector verified the inspection records and maintenance sheets for the smoke detector. The smoke detectors were not verified. Discussion with the administrator to consult with the centre as to how they can make sure the smoke detectors are verified each month and then to be documented on the sheet.

Comments: During the follow-up inspection, the inspector observed children with no shoes. As per the amendments of the Act. children should wear proper indoor footwear at all times. The educators immediately placed shoes to children. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed a gallon of paint in an unlock cabinet in the afterschool room. The administrator immediately locked the gallon of paint in a locked cabinet. Deficiency is now compliant.			

**General Comments**

During the follow-up inspection, inspector observed indoor free play and the preschool playing in the gym. Inspector observed the educators allowing the children to freely choose the activities in which they were interested. Inspector observed positive interactions between the educators and the children.

A discussion with the administrator regarding the professional learning hours. Each staff is responsible to have a copy of their professional learning certificates in their files.

The ratio was respected at all times during the follow-up inspection.
