Comments: During the monitoring inspection, the Quality Assurance Monitor observed that a staff member had a contravention indicated on their social development check. The administrator had a discussion with the employee and the employee was asked to leave the premises. The Quality Assurance Monitor has reminded the administrator that the employee cannot work in a daycare unless they have a social development check that is clear of contraventions. The administrator has confirmed that only staff who do not have contraventions will be allowed to work in the facility. Deficiency is now compliant.

The administrator shares that the tarp has been damaged by the hurricane and that they will repair it and will place it back when the rain stops and the warm temperatures return. Deficiency is now compliant

The administrator shares that they will ensure that more material is added.</p>
