General Comments

During the renewal inspection, inspector observed the children arriving from school, indoor play, outdoor play as well as snack time. Inspector observed children engaged in an activity organized by the educator (making crafts out of clay), while other children chose free play. Inspector observed the educators respecting the children's needs by offering the children more food upon the request.

Inspector observed that the substitution to the menu made on November 20th 2023 is documented "nachos, salsa and popcorners" on the menu in the classroom. However, the substitution to the menu located in the kitchen is indicated as "odds and ends". Inspector recommends that this documentation be more precise.

Administrator must ensure that a new copy of the facility's general liability insurance is provided to the inspector before the renewal of the license.
