Comments: The inspector observed that the fire drill practice for November had not been completed. The administrator stated that the facility will conduct 2 practices for the month of December.				

General Comments

During the visit, the inspector observed children having lunch, nap time, and engaging in indoor free play. The children washed their hands before eating.

The administrator must ensure that all the personal belongings of the child is labelled.

The inspector observed a printable name-tracing sheet in the art section in one classroom. The inspector informed the administrator that this practice does not align with the Curriculum Framework. To support the facility and offer other practices, the inspector will contact the Early Learning Consultant.

One educator has not yet completed the required 10 hours of professional learning and has until December 31 to fulfill this requirement.

The outdoor play area was not inspected during the inspection; it will be verified at a later time.
