A Monitoring Inspection was completed this morning. Upon arrival, children were observed inside, during free play. Children were observed playing with babies and preparing the babies, for a camping trip. Children were observed building tracks and playing with cars. Children were also observed building with Lego and making nametags. Children were observed sitting at a table, looking through transportation themed books. Educators were observed sitting with the children, taking part in play. Some well-defined learning / play centers observed, but more to be added. Some forms of documentation observed. QAM will be looking for more summer themed documentation at the next monitoring inspection. Educators were observed helping the children transition to

outside play - assisting with water shoes and sunscreen. While outside, children were observed playing in the sandbox, playing at a water table, with freshly hosed water, and playing with toy vehicles. A conversation was had with operator regarding the standing water, in the outside play area - inside tires, play kitchen, house, and bucket. Standing water to be emptied each morning, before outside play.
