## **General Comments**

Licensing staff arrived to conduct the annual renewal inspection. Upon arrival, the children from each classroom were having their morning snack. The children were sitting together at tables in each classroom and Educators were attentive to their needs.

As the children finished their snack in the preschool age room, the children washed their hands and joined an Educator for a Thanksgiving painting craft. In the infant room, the Educator was observed describing images on the wall and encouraging them to choose books from the shelf. In the 2-year-old room, the Educator was observed assisting the children tidy up their space at the table and prepared to go outdoors. Before going outdoors, bathroom time and proper handwashing was observed. There was evidence of daily routine as each classroom staggered leaving their classrooms and "hands on the window" was heard as the children lined up outdoors before proceeding to the outdoor play space.

The outdoor play space was fully fenced and secured with a gate. Play material in the infant space and preschool age space varied and was in good condition. Shade sails were still in place and the protective surfacing surrounding the play climber in the preschool age space was the correct depth. While outdoors, the preschool age children were observed playing at the mud kitchen, using a large tug-of-war rope as a fireman hose, and looking for insects. The infant children were observed playing on small slides, with at an outdoor kitchen and with trucks.

As the children returned indoors, outdoor footwear was changed, coats and hats were hung up, and the children were observed playing freely while Educators prepared the tables for lunch. During lunch time, the children sat together, and Educators were engaged in conversation with the children and assisted with packages. As the children finished eating, Educators were observed setting up nap cots and a pack and play for one infant. The transition to nap time was smooth. The children in the 2-year-old room chose books to read while waiting for their friends to settle on their cots. The overhead lights were turned off, soothing music was played, and twinkle lights were turned on. It is recommended that a curtain be added to the 2-year-old room on the main door as the sun was very bright and the Educator used a parachute to cover the door.

During inspection, staff and child files were verified. Allergy information was posted and the bulletin boards in
