The Quality Assurance Monitor is on site for a monitoring inspection. This is the Quality Assurance Monitor's first visit after the change in directors of the corporation.

The Quality Assurance Monitor verified new staff member's files.

Children were playing indoors at the time of the inspection.

A conversation was had with the staff in charge regarding offering services to the after-school children. It was mentioned that the operator wants to do renovations to the after-school space. The Quality Assurance Monitor reminds the staff in charge that an application for change with all required documents must be submitted to the department before commencing any type of renovation.

The staff in charge also mentioned to the Quality Assurance Monitor that the class in the middle of the facility (after-school space) was occasionally used by infant and preschool children. That space can only be used for after school children, due to an exemption regarding windows.
