Comments: During the follow-up inspection, no items were observed blocking the emergency exits. Cots were appropriately relocated during naptime. Deficiency is now compliant

Comments: The Quality Assurance Monitor observed that the unstable and unsafe picnic table in the outdoor play area had been removed. Deficiency is now compliant

Comments: In the infant outdoor play area, an additional surface was added, providing children with more options to engage in various types of play. Deficiency is now compliant

Comments: Art materials were relocated to a low, open shelf, making them easily accessible to children, as observed during the follow-up inspection. Deficiency is now compliant

Comments: Documentation of a monthly review and maintenance plan for the stationary equipment was observed during the follow-up inspection. Deficiency is now compliant			
36(4) The rest area of a full-time early learning and childcare centre and an early learning and childcare home shall allow for a space of at least 46 cm between each crib, portable playpen, cot or nap mat.	36(4)	May 15, 2025	Jun 10, 2025
Comments: During naptime, the Quality Assurance Monitor observed that the space between nap mats was at least 46 cm. Deficiency is now compliant			
48(4) If an infant is receiving services at a licensed facility, the operator shall (d) ensure that each bottle is stored with a cover in the refrigerator.	48(4)(d)	May 21, 2025	Jun 10, 2025
Comments: The infant bottle that had not been refrigerated during the previous visit was stored properly in the refrigerator during the follow-up inspection. The operator contacted their Public Health Inspector and was informed that NB recommends mixed formula be consumed immediately or refrigerated and consumed within 24 hours. Any prepared formula left out for more than two hours should be discarded. The operator and the parents agreed to follow best practices. The educators will mix the formula at the facility and refrigerate if needed. Deficiency is now compliant			
49(1) An operator of a licensed facility shall ensure that the guidance of the children receiving services at the licensed facility is positive and includes positive reinforcement, encouraging efforts and recognizing accomplishments.	49(1)	May 14, 2025	Jun 10, 2025
Comments: The Quality Assurance Monitor spent time in the classrooms during naptime. Children were not required to remain on their mats, and those who did not wish to rest had access to quiet activities. Educators used a positive and respectful approach. The administrator also informed the Quality Assurance Monitor that all staff members had reviewed the section on positive child guidance in the Operator's manual.  Deficiency is now compliant			

General Comments
<p>The Quality Assurance Monitor is on site for the follow-up inspection. Children were observed eating lunch and napping. Another microwave was added to support lunch preparation and reduce the amount of time children had to wait for their meals. No use of technology was observed during lunch preparation. Instead of having children sit and wait, indoor free play continued during this time, allowing them to remain engaged.</p> <p>The Quality Assurance Monitor had a discussion with the administrator regarding emergency contacts in the child profile. 120 days from start date was given to complete the emergency contacts for one family. The Quality Assurance Monitor will follow-up with the administrator.</p> <p>All previously identified deficiencies are now compliant. Renewal of the license is recommended.</p>
