Comments: Deficiency is now compliant. Licensing staff observed toxic products cabinet was not locked. This was corrected during my visit.			

<p>General Comments</p> <p>Monitoring inspection performed.</p> <p>Upon arrival, most school age children were finishing snack. Educators set up stations for children to participate in. Licensing staff observed some children building with lego blocks another group was coloring pictures in their journal books. Each child has their own booklet.</p> <p>Children are in a countdown to March break - The centre will be offering a March break camp on "Art Explorers". Any child that signs up will be studying a major artist each day. The operator is also planning ahead and sending out Summer Camp flyers.</p> <p>Licensing staff observed stained tile in a couple of places. The Owner indicated that she has communicated with the landlord on several occasions about the leakage in the ceiling tiles and during warm winter days, it leaks water inside the facility. This is a general health concern under our regulations, and this will need to be repaired.</p> <p>Children are familiar with the routine. The lead educator uses a count down system for transitioning 10, 9, 8... and everyone moves to the mat and sits down. The lead Educator discusses the afternoon activities and instructions are given using language that is easily understood by all in attendance. Licensing staff recommends using a signal to get children's attention, so the educator is not having to raise their voice above the children's voices. Children were excited as they were going to get ready for outdoor play at the school park and taking their spray bottles so they could make designs in the snow. Today's topic was on Black History Month and the children were listening and learning about Oprah Winfrey and why she is a super interesting person and her accomplishments. Children were engaged and asking questions. The educator also gave children an opportunity to discuss their weekend plans and everyone who wanted to participate could talk about it, while</p>

others listened. This week has been on the topic of Pets and after return from the park, they will be making pet collars for their stuffed dog toys.
Positive language was used, and educators were observed saying turn on our listening ears, no thank you.
Administrative records were reviewed and licensing staff also updated new staff info.
