Comments: Operator completed the daily attendance sheet during inspection. Deficiency is now compliant.			

<p>General Comments</p> <p>During my inspection the children remained indoors due to the weather. Children were observed playing with sensory bins of kinetic sand with small loose play pieces, throughout the room with various material and painting rocks. The Operator was engaged with the children and was observed asking the children which colours they were going to use and encouraging them to spell the word "rock" out loud before starting to paint.</p> <p>The space was clean and organized. Play material such wooden blocks, a play kitchen, a fruit and veggie stand with accessories, trucks, cars, and a large doll house with accessories were in good condition. The bookshelf and cozy reading space were tidy and labelled bins of flash card, animals and puzzles were on easily accessible shelves. Later in the morning, some of the children were observed playing with a wooden train table, reading a book, and pretending to cut up wooden fruit pieces on the floor with the Operator. The Operator used expressive and kind language while encouraging imaginative and fine motor skills play. There is evidence of a daily routine as the transition between activities was smooth and material was cleaned up before starting something new.</p> <p>There were learning stories, photos and children's artwork on display near the main entry way and web planning is being used for planning weekly activities. The parent board contained all required documentation. The menu is posted for daily provided snacks and meals and changes/substitutions are communicated to parents verbally. Files were verified, and all required documentation was in order. Monthly fire drills and outdoor maintenance checks are being completed and recorded. The outdoor play area was icy due to the recent change in weather. Please ensure to use sand or salt to avoid slips and falls.</p> <p>Licensing recommends for renewal.</p>
