<p><b>General Comments</b></p> <p>A Monitoring Inspection was completed this morning. Infants - The babies were getting ready for a walk at QAM's arrival. Twos - Children were observed finishing up their snacks. Today's snack was crackers and cheese. After snack, children were observed sitting in the cozy reading corner, on a couch, looking at books. Educator was observed reading to the children. Twos / Threes - Children were observed playing in the outdoor fenced in play area. While outside, children were observed kicking soccer balls, bouncing balls, and pushing toy vehicles. Half Day Preschool – Today was the educator's last day. Children and parents were observed giving the educator cards, treats, and gifts, at drop off. Three / Four - Children were observed both inside and out. While inside, children were observed sitting together, singing, counting, and answering the question "What is your favorite food"? Children were observed during snack, and during outside play. Several forms of documentation were observed throughout the facility - learning stories, photos of the children taking part in activities, children's artwork, and word webs. Educators were engaged with the children - preparing children for transitions, anticipating children's needs, giving gentle reminders, and using positive language when interacting with the children.</p>
