<p>General Comments</p> <p>A Monitoring Inspection was completed this morning. Children were observed both inside and outside.</p> <p>3-4 Year Olds: The 3/4 room had several well-defined learning / play centers - cozy reading area, dramatic play, building & animals, arts & crafts, vehicles & dinosaurs, and dress up. Several forms of documentation were observed throughout this classroom. Positive child guidance techniques were observed - educators giving gentle reminders, preparing children for transitions (hand washing, snack, and getting ready for outside play), and using positive language when interacting with the children.</p> <p>2-3 Year Olds The 2/3 children were playing outside at QAM's arrival. Children were observed returning to inside play. Children were observed washing their hands upon re-entering their classroom. Positive child guidance techniques were observed - educators assisting children with getting their outdoor clothing off, anticipating children's needs, and using positive reinforcement and encouragement.</p> <p>2's Classroom The 2's were on a field trip this morning. They went to a tree farm, to pick out a classroom tree.</p> <p>Infants Infants were finishing up their snacks at QAM's arrival. Educators stated that the infants are presently interested in the car track, cars, and balls. Infants were observed playing with balls and looking at books.</p>
