Children were observed using crayons, stickers, buttons, and glue. A conversation was had with educator regarding small parts, and how children must be supervised at all times, when utilizing them. Educator was observed giving proper supervision.</p> <p>2/3 Room - Children were observed during outside play. New additions have been added to the outdoor, fenced in play area. A big red jeep, a mud kitchen, and a new sunshade were some of the newly added additions.</p> <p>3/4 Room - Children were observed during inside play. Children were observed playing with bugs, babies, and puzzles.
