<p>A Monitoring Inspection was completed this morning.</p> <p>Infants - Children were observed sitting at their table, eating snack, with their educators. After snack, children were observed playing outside, in the larger fenced in play area. Educator stated that the children are presently interested in coloring, stickers, and going on walks.</p> <p>Twos - Children were observed playing with babies and the magnetic writing boards. A conversation was had with administrator regarding the placement of paper. Administrator moved the paper to an area that was more accessible to the children. Educator stated that the children are presently interested in arts & crafts, anything sensory, and playing outside.</p> <p>Two/Three - Children were observed sitting at a table, with their educators, eating snack. Apples, grapes, and Graham Crackers were served as snack. Prior to snack, children played outside, in the fenced in play area. Educator stated that the children are presently interested in walks and outdoor adventures.</p> <p>Three/Four - Upon arrival, the children were observed during free play - building with foam bricks, cutting paper, and playing with toy vehicles and animals. Children were observed making apple muffins with an educator and preparing for snack.</p> <p>Each room contained several forms of documentation - learning stories, open ended art, and photos.
