General Comments A monitoring inspection occurred on January 29, 2025. All new staff files were reviewed and verified complete once the Educator returned with the new Vulnerable Sector Check. Mandatory attendance records were reviewed and verified complete. Infants, 2's and 2/3's were observed finishing lunch and during nap/quiet time. The 3/4's were observed during lunch, inside play and outside play.

General Comments

Discussed with the Educators and Administrator during the inspection to check the weather during cold days to ensure that children are still able to go outside.

Regulation 22 The Daily routine of a licensed facility shall include:

(a) outdoor play for at least one hour in each four-hour block of time when the majority of children receiving services are in attendance except in the following circumstances:

- (i) the windchill is below -20 Degrees Celsius;
- (ii) the temperature is below -20 Degrees Celsius;
- (iii) the temperature is 33 Degrees Celsius with humidity or above;

Educators should be mindful and observant of changing weather and monitor the children to ensure properly dressed or if they are becoming cold on cold winter days and to bring the children in early if necessary to prevent frostbite.
