### General Comments

Upon arriving at the facility, the children were engaged in free play activities after having lunch. The children were playing "family" in the dramatic play kitchen, others played with Legos and Pokémon cards. The educators were observed engaging in the children's activities while supervising.

After a few minutes one educator asked the children if they were ready to continue the "detective" activity. The children said yes and educator gave the children a verbal prompt to start cleaning up. After cleaning up, the children gathered on a large blue carpet near a white board. An educator then sat down on the couch near the white board and began the "detective" game. The children and they educator engaged in all of the clues and situations to determine who "stole the cookies". After going over all the clues and discussing the possible suspects that were represented as animals, the children came to a group decision of who "stole the cookies". To conclude the activity, the children went over to a large board and moved ahead a picture of the animal that they thought was the key suspect.

After playing the "detective" game, the educators prompted the children to gather and fill their water bottles and use the washroom before going outside. The children agree and once ready, lined up against a wall near the door. An educator was observed completing a head count before going outside with their daily attendance sheet, first aid bag and sunscreen for the children. Once outside, the children applied sunscreen and engaged in free play activities.

While outside, some children played on the large play structure while others played "jackpot" with a rubber ball and used their hats as gloves to catch the ball. The educators ensured that the children who had sunscreen properly applied it before playing. The educators were observed floating from group to group to ensure they were supervised. Some children engaged in "mud kitchen" activities such as making cakes, cupcakes and soups while others played basketball. The educators were observed supervising the children while they used the washroom and re-filled their water bottles.

The indoor environment was clean and well organized. The children's personal belongings were properly labelled and stored. Play materials such as gears, Legos, magnetic blocks, dolls, and toy animals were available at an accessible height and were sufficient for the number of children. Some of the children's artifacts

were posted on a bulletin board along with an "Astro Ball" game. The parent information board was verified and found to be complete. The monthly fire drills have been complete along with monthly playground check. Seven child profiles were verified and were found to be complete.
