## **General Comments**

QAM observed younger group arriving after playing outside; all children playing playdoh or coloring; snack being served to the younger group; children play in 3 centers that were set up by educators (1 with connect four, 1 with Legos, and 1 with dinosaurs and play houses). Educators were engaged with children in the centers. QAM also observed older group of children arrive and eat snack, then begin playing a game. QAM also observed children take a yoga break.

QAM discussed with administrator the need to allow children free choice of toys and art materials, and to have toys on low open shelving for freeplay.

QAM recommends that Administrator does a check of staff files to ensure that all required paperwork is located on-site and organized.
