Child was given extra peanut butter, cheese, and pretzel crisps.</p> <p>Children were very engaged in a science experiment involving guessing what is inside balloons.</p> <p>Quality Assurance monitor observed one child that decided they were done completing the science activity and moved into freeplay. Several children continued squishing the balloons after the experiments was completed.</p> <p>QAM observed educator helping children to work out an issue between them in a kind way.</p> <p>Discussion with inclusion support worker on tools and resources for the children she is working with.</p> <p>Children playing freeze dance, the floor is lava and various group games.</p> <p>Toy cupboard is open, children had access to all toys during inspection. 3 tables were set up with various activities including crafting, board games, and a water sensory table.</p>
