<p>Comments: The inspector observed that two staff members hold certificates approved by WES but are not recognized by the Minister. Both staff members have only completed the 30 hours Orientation to Early Childhood Education certificate. Any employee who does not hold an Early Childhood Education certificate must have completed, or be registered in, the 60 hours curriculum. The administrator completed the exemption form and submitted it to the exemption team to request recognition of the staff member's certificates. If the exemptions are not approved, both staff members must be registered in the 60 hours curriculum.</p>

<p>Comments: The inspector reviews all employee files and observes that one employee file only has the criminal record checks. Each staff member must obtain a criminal record and vulnerable check prior to employment. The employee left site to go to the RCMP station and obtain those checks while the inspector is still on site. Deficiency is now compliant.</p>

<p>Comments: The inspector reviews all employee files and observes that one employee file is missing the description of duties and responsibilities. All staff member records must include a description of duties and responsibilities. The administrative gave the sheet to the employee to read and sign it and place it into the employee's file. Deficiency is now compliant.</p>

<p>Comments: The inspector reviews all employee files and observes that one employee file only has the criminal record checks. Each staff member's record must include a copy of both criminal record and vulnerable check prior to employment. The employee left site to go to the RCMP station and obtain those checks while the inspector is still on site. Deficiency is now compliant.</p>

<p>Comments: The inspector observes in the infants and one preschool classroom art materiel place on high shelves. All indoor play materials and equipment must be easily accessible to children and on low open shelves. The inspector informed the educator who placed the art material on low open shelves, the children now have access to the material. Deficiency is now compliant.</p>			
<p>36(4) The rest area of a full-time early learning and childcare centre and an early learning and childcare home shall allow for a space of at least 46 cm between each crib, portable playpen, cot or nap mat.</p>	<p>36(4)</p>	<p>Apr 22, 2026</p>	<p>Apr 22, 2026</p>
<p>Comments: The inspector observed in both preschool classrooms, two mattresses are placed next to each other. All rest equipment must be spaced at least 46 cm apart. The inspector informed the educators, who repositioned the beds. The beds are now spaced 46 cm apart. Deficiency is now compliant.</p>			

General Comments
<p>The inspector is on site to conduct the renewal inspection.</p> <p>During the inspection, the inspector observed the morning snack period, one classroom using the gym area for dancing activities, and another classroom transitioning to outdoor play.</p> <p>The inspector also observed the morning outdoor play, lunch period, rest period, the arrival of school age children from school, afternoon snack, and afternoon outdoor play.</p> <p>A discussion is held with the administrator regarding the requirement that all children's personal belongings be clearly labelled with the child's name.</p> <p>Another discussion is held with the administrator to ensure that fire drills are conducted monthly. It was noted that a fire drill was not completed in August 2025. However, fire drills were conducted for the seven months following August.</p> <p>Positive child guidance is observed during the inspection, including educators engaging with children at their level and communicating in a calm and respectful manner.</p> <p>The ratio is respected throughout the inspection.</p>
