General Comments
<p>Licensing staff arrived at the early learning and childcare home to conduct the annual license renewal inspection. Upon arrival, the children were engaged in free play activities. Shortly thereafter, the children washed their hands and prepared for the morning snack.</p> <p>Following the morning snack, the children dressed appropriately and transitioned outdoors for active play. While outside, the children participated in group games, including hide-and-seek, and worked collaboratively to gather logs for a pretend bonfire, demonstrating imaginative play and cooperation.</p> <p>The children returned indoors for lunch. The lunch menu consisted of fish sticks, sweet potatoes, shredded cheese, cucumbers, and milk. During mealtime, the operator read a storybook to the children, supporting language development and maintaining a calm and engaging atmosphere.</p> <p>After lunch, the children participated in additional free play activities while the educator cleaned and organized the environment.</p> <p>Throughout the inspection, the operator consistently used positive child guidance strategies. The operator encouraged children to problem-solve with their peers, supported the use of appropriate language to express emotions, and maintained a kind, gentle, and respectful approach in all interactions.</p> <p>The indoor play environment was inviting, and multiple play centres were available for children, and several examples of children's learning and work were displayed on the walls, reflecting ongoing programming and documentation of learning experiences.</p> <p>All required documentation was posted just inside the entrance of the home and was readily accessible. Overall, positive child guidance practices were observed throughout the inspection, and the environment supported children's learning, development, and well-being.</p> <p>Licensing staff recommends the ELC Home for renewal of license.</p>
