When QA Monitor arrived, children were enjoying the splash pad before returning to the centre for lunch and nap/quiet time.</p> <p>Webs posted in indoor play environments highlight interests, knowledge and activities. Children's portfolios include learning stories and photo documentation of recent activities and learning. Documentation posted in the entry way of the centre highlights a collaboration with Talk with Me that provided an opportunity for educators and children in the infant room to learn sign language over a 6 week period. What a great way to foster relationships between the facility and local community partners.</p> <p>Storage shed in the outdoor play area in need of tidying and sorting so that materials are easily accessible for staff to create invitations and provocations for the children.</p> <p>As discussed, please contact QA Monitor to schedule an inspection when the upstairs bathroom is ready.</p>
