Monitoring Inspection:

The school-age children were observed playing at the playground. The children were observed playing on the playground equipment, playing soccer and basketball, exploring the mud kitchen, chasing each other, and relaxing in the shade. The educators were observed spaced out around the playground ensuring adequate supervision was maintained. The Educators were observed conducting frequent head counts of the children. The Educators were observed having positive conversations with the children.

In indoor environment had a variety of learning interest centers and materials for the children to explore. The Inspector observed on-going lego creations and cardboard housed using a wide range of open-ended materials such as macaroni, felt, pipe cleaners, corks, beads, pom-poms, fabric, and wood. The administrator shared that the school-age children enjoy playing board games and having glow in the dark karaoke dance parties.
