## **General Comments**

Children were outside playing when I arrived for today's renewal inspection. Children were observed playing with trucks and exploring different ways to get ice out of a sled.

When it was time for children to come, educator set up an activity which consisted of a sensory bin filled with cotton balls, pompoms, spoons, and paper towel rolls that were decorated as snow men. Children were excited

to try and scoop up the "snow" and fill their snowman tube!

Operator has a dog and a cat in the family home. Animals do not have free access to children's play area. Proof of current vaccinations was provided to licensing staff at time of inspection. A reminder to ensure to have your dog's vaccination papers printed for easier access.

The ELC home's indoor environment offers a bright and caring atmosphere for children to grow, learn and thrive in. There are many learning stories posted throughout the facility of children's activities and accomplishments. The indoor environment is also set up in a way that promotes independence by having all play material on low shelves so that the children can pick and choose what they wish to play with.

Observed operator providing children with lots of praise and encouragement throughout entire inspection. Operator was observed ensuring she was getting down to children's level when speaking to them. Based on observations from today's inspection, it is recommended to change child on a mat on the floor due to safety concerns.

Observed permission slip in child's file for child over 15 months of age to remain sleeping in a play pen. Please ensure child's size and weight still meet the requirements of the playpen. Should child outgrow playpen or weight restriction, they are to be transitioned to a cot?

A reminder that when napping children are not directly supervised, a physical check of the children must occur every 15 minutes. These checks are documented with operator signature and the times of the check. Baby monitors are recommended to ensure the safety of children when napping unsupervised. Operator to begin documenting safety checks immediately.

A reminder that when children are resting, but remaining awake, they must not be required to stay on the mat or bed for longer than 30 minutes and must be closely supervised.

A reminder that it is important that parents/guardians understand the importance of having two emergency contacts who are authorized to pick up their child and to be contacted in case of an emergency if they cannot be reached.
