General Comments

A renewal inspection occurred today.

The children were observed playing board games, building with blocks, and reading stories. The children then cleaned up, washed their hands, and were invited to have crackers, carrots, and ranch for snack. When the children were done snack, they grabbed their outdoor materials and went outside. The children were observed playing on the playground and playing in the mud with kitchen utensils, pots, pans, and bowls.

Documentation was displayed around the classroom environment. Licensing staff discussed the idea of adding a write up and including the date that the play occurred with the administrator. Recommending that the educators create a binder to store previous play experiences for the children and families to be able to revisit.

The educators were observed engaging in conversations with the children. The licensing staff discussed sitting with the children when they are having snack.

The licensing staff discussed with the administrator having more opportunities for the children to explore the arts
