Comments: The inspector observed one child access the parking lot when the second children drop off from school arrived on the school bus without direct supervision. The educator responded immediately by joining the child outdoors. For the safety and well-being of the children, child-to-staff ratios and active supervision is to be maintained at all times. Deficiency is now compliant

Comments: The inspector was onsite to complete the follow-up inspection. The administrator advised that Hildegard Park continues to be used as an alternative outdoor play space as the center's outdoor play area has not yet been repaired. Children do not have access to the outdoor play area until it is repaired, properly maintained, and free of hazards. The administrator estimates repairs will be completed within approximately one additional week.

The inspector was onsite to complete the follow-up inspection and observed children arriving from school, having snacks, followed by educators actively participating with the children in a group game on a large,

carpeted area. The administrator advised that due to required repairs to the center's licensed outdoor play area, children will be taken to Hildegard Park for outdoor play prior to parent pick-up.

During the follow-up inspection, an educator asked the inspector to supervise the children while she went outside to bring additional children indoors. The inspector explained that educators are responsible for maintaining supervision and always require child-to-staff ratios and must not rely on other individuals to supervise children under their care unless they are educators, administrators or operators.
