Comments: While conducting the license renewal follow-up inspection, licensing staff noted the knicks, in multiple places, in the wall are not repaired from the license renewal inspection from April. Please repair all knicks in the wall as soon as possible.			
31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.	31(3)	Jul 15, 2025	
Comments: While inspecting the outdoor play environment, licensing staff noted a broken pipe that is sharp and sticking out of the cement at the back right corner of the outdoor environment that is of concern and will need to be repaired immediately as this poses to be a safety hazard for the children. Licensing staff also noted the stairs and landing for the fire exit has not been repaired. Please repair this as soon as possible.			
33(1) An operator of a licensed facility shall provide outdoor play area materials and equipment that are varied and in sufficient quantity for the number and ages of the children receiving services at the licensed facility.	33(1)	Jul 31, 2025	
Comments: Licensing staff noted that the multiple sand boxes located in the outdoor play environment does not have sand and sand toys for the children to play with. Please add sand and sand play materials such as shovels, spades, buckets, rakes, etc., for the children to play with while outdoors. Also, more play materials need to be added or taken outside when the children go outside to play.			

General Comments

Licensing staff arrived at the licensed facility to conduct a follow-up license renewal inspection to check if the compliance orders from the license renewal inspection that was conducted on April 25th, 2025, were corrected.

Licensing staff noted the stairs and landing leading into the entrance of the licensed facility were repaired since the license renewal inspected. The broken wooden spool has been removed from the outdoor play environment and the protruding screws have been removed from the garden box.

Child-to-staff ratio during the follow-up inspection was within regulation as per the Early Childhood Services Act.

General Comments

Licensing staff also observed completed files for the three new educators that were onsite supervising the children.
