## General Comments

Upon arrival the children were playing outside in the outdoor play space. The amount of learning centres and materials that are available to the children is more than sufficient. The areas include a huge chalk board, a music wall, a sensory table, a kitchen area with recipes included for mud cake flower soup and dirt soup, an airplane structure, a funnel, a water well, dramatic play, dinosaurs, a train, a boat, paint, a car ramp, a cozy area, with books, swing sets and climbers. Underneath the deck, there is a fabricated fairy garden with plants, rocks, gnomes, wood, chairs and string lights. There is also a garden where the children have planted vegetables and are free to pick them as they desire. The operator has centres physically labelled as to what they contain and charts outlining processes such as the tomato plant growth stages.

As soon as you walk into the home, the operator has the entrance set up with labelled, individual storage for the children. There are framed pictures of the children, pictures, and each child has a bag with their learning stories in it. The entrance invites the parent(s) to learn about their children's day and displays the operator's interest in learning about the families of the children in their care.

As you walk into the facility, the art area has an abundance of materials, a gross motor area, a calm nook area under the stairs, a science area, a ball drop area to name a few. The Operator stated that when the children ask for something or need something she gets it and this is evident throughout the facility.

The child guidance that was visible on the day of my visit can be described as a learning opportunity for the children. The Operator remained engaged and provided direct guidance when needed at the level of the children. One of the children had taken a toy from another child and the child became very upset. The operator intervened and said "your friend is using that toy right now, do you want a turn after they are done using it"? The Operator told the child without the toy to ask his friend if they could have a turn. The child asked and the child with the toy handed to them.

The operator remained child focused for the duration of the visit. She directly engaged with the children and offered encouragement and guidance as needed. The Operator is webbing and idea jotting to build on the interests of the children. This was evident in the planned program and environment of the home.

General Comments							
The loft is now usable space for quiet play. All safety concerns were rectified as stated in a previous report.							
The operator maintains all documentation that is required in an organized and complete manner. I can now recommend for licensing.
