<p>General Comments</p> <p>Licensing staff visited to discuss change in service and provide information on what documents are required. Due to difficulty with busing afterschool children to the facility and an increased need for infant spaces, the facility has registered six additional infants 15-24 months and are using the room that was previously approved for school age children.</p> <p>Children were just waking up from nap in many rooms and children that were awake were combined in one room. Ensure that staff-to-child ratio is always maintained throughout the day and the staff-to-child ratio does not exceed two educators.</p> <p>The administrator visited each room with licensing staff to view the facility and meet educators in each room. Several new educators were present, so licensing staff reviewed each of their files. Ensure educators receive a copy of their job description and sign the signed statement before starting work as an educator. All staff need to have valid first aid from an approved first aid provider and not to be left alone with children until completed. Two new staff have criminal record/vulnerable sector checks from other provinces and need to complete checks in New Brunswick.</p>
