General Comments

This is a new afterschool program.

This is the licensing inspector's (Quality Assurance Monitor) first visit to the afterschool program that commenced operation on Monday October 30th. A small group of children was observed during the visit playing cooperatively. The administrator was engaged with children and supervision was appropriate. There are 2 classrooms that have been approved for operation, but currently only one classroom is being used, so there is lots of room for this school age program to grow.

During the visit, the Licensing staff reviewed staff files, and attendance records. It was observed that the staff Page 1 of 2

file was incomplete, but this was corrected. The administrator also has other administrative records stored in a binder and ready when needed - incident, potential illness, fire drill, first aid forms etc for tracking. The administrator is very organized.

The administrator showed me a Halloween pumpkin activity the children participated in yesterday which she has posted on a private FB page to parents. She is also documenting programming and printing the activities with pictures of the children and keeping a record of the learning activities on site.

The space is used by another group in the evenings, so the Operator has a plan in place to hire additional staff to help with setting up the space on a daily basis and locking things away at the end of the day.

Licensing staff indicated they would follow up on the license as they have not received this in the mail.
