General Comments

Licensing staff arrived to conduct the renewal inspection. Upon arrival, the 0-14m infant classroom had just finished morning snack, while the other classrooms were preparing to go outdoors.

Each indoor classroom was bright and inviting. Play material such as wooden blocks, loose play pieces, books, and art supplies were organized, easily accessible, clean and in good condition. There were elements of nature incorporated throughout each classroom and the hallways had children's artwork and current learning stories on display. Educators were observed conducting headcounts before leaving the indoor classrooms to go outdoors to play. Water bottles, the attendance log, and first aid backpacks were all taken outdoors.

The outdoor play space was fully fenced and secured with a latch for both the infants and preschool age children. The preschool age children were observed playing on the swings, with cars, balls, jumping and singing. Educators were actively engaged with the children and were observed offering comfort and hugs after a tiny tumble. The infant space was well shaded with two shade structures and Educators were observed sitting with the children building with colouful blocks, offering assistance on the small slide, and were heard engaging in conversation. The transition from the outdoor space to indoors later in the morning was smooth. Headcounts were observed and once indoors and footwear was changed.

Before lunch, the children from each age group washed their hands and proper diaper changing procedures were followed. Tabletop activities, songs, and games were observed while Educators prepared lunch items. During lunch, the children were observed sitting together and Educators were attentive to the children's needs. During nap and quiet time, calm music was heard playing and children who did not sleep played quietly with puzzles, books, and in the indoor sandbox. After nap time, the infants were observed playing with balls, trucks, and snuggling with Educators while the preschool age children coloured, traced magnet tiles and prepared for afternoon snack.

General Comments

During inspection, there was evidence of a daily routine and purposeful planning. Child and staff files were verified, and all required documentation was present. Monthly fire drills and outdoor checks are being completed and cleaning checklists as well as emergency evacuation plans are posted in each classroom. The posting board in the main entry was organized and licensing documentation visible. As a reminder, inclusion support workers providing services do not count in the ratio; however, the child remains counted in the ratio. A discussion occurred on site with the Director and ratio was corrected.
