Room #1 has also added dramatic play materials and sensory opportunities.</p> <p>Room #6: Sensory opportunities lacking within environments. QA Monitor left challenge with staff to add sensory opportunities to the environments each day. Examples of items to add, but not limited to water, sand, rice, slime, playdough, etc. Discussed creating premade sensory bins that are easy for educators to grab and add to their rooms. Previous comply by date - Oct 21, 2024.</p> <p>Dramatic play materials depleted. Examples of items to add, but not limited to costumes, hats, scarves, purses, office supplies, restaurant items, clipboards, cash register, money, pretend food, real life items, loose parts, tools, items that support the children's interests.</p>
