Comments: Bleach was observed to be stored in a cabinet with a broken lock. QA Monitor discussed with staff during inspection and bleach was immediately moved to a cabinet with a working lock. Deficiency is now compliant.

<p>Monitoring Inspection - PD Day:</p> <p>Room #1 is the only room operating on this license currently.</p> <p>Children and educators observed during transition to outdoor play this afternoon. Staff were observed taking small groups out as they were ready in their winter clothing to avoid long wait times. Educators were observed offering children choices and redirecting their behaviors. Children were observed engaging in outdoor play in the snow this afternoon.</p> <p>QA Monitor noted that recommendations from last Monitoring Inspection have been implemented regarding sensory and collage materials. Accessories for pouring, scooping and measuring have been added to the sensory bin. A variety of collage materials are now accessible on the art shelf. Documentation is displayed throughout the environment that supports the children's current interests (restaurant, Christmas and baking). Open ended art pieces and photos of the children are displayed.</p> <p>Cereal was served for snack this afternoon.</p> <p>Handwashing routines were observed during washroom routines.</p> <p>Monthly fire drills are documented.</p> <p>Daily attendance records are accurate and reflect all children present. Child-to-staff ratio was observed to be met during Monitoring Inspection.</p>
