During the inspection, it was observed that 6 out of 20 lunch boxes checked were missing the child's name. The administrator must ensure that all lunch boxes are clearly labeled with the child's name. The educator immediately added the missing names.

The Quality Assurance Monitor was on site for a monitoring inspection during mid-morning and part of nap time.

The following elements were verified:

- Washroom
- Diaper Changing Area
- Storage Space
- Personal Belongings
- Nutrition
- Outdoor Play Area
- Outdoor Play Area Materials & Equipment

The Quality Assurance Monitor had a discussion with the administrator regarding designation requirements. The administrator confirmed that the Quality Improvement Plan is current and that all eligible educators are actively completing their required 10 hours of professional learning per renewal year.

During the inspection, it was observed that one out of four tires in the outdoor playground contained water. The administrator must ensure that all tires are emptied daily to reduce the risk of contamination, prevent mosquito breeding, and maintain compliance with health and safety regulations.

While inspecting the outdoor play area, the Quality Assurance Monitor observed that one of the boards on the

platform in the infant area was loose. The QAM recommends monitoring the board to ensure it does not pose a risk to children and addressing it promptly to prevent further deterioration.

During the inspection, it was observed that two potty seats were on the floor. The administrator must ensure that they are properly sanitized and stored off the floor to maintain hygiene and prevent contamination.

There was a discussion with the administrator about whether there were any allergies. within the facility and if they were posted. The administrator mentioned that she was informed that morning that a child in the facility had an allergy. The administrator promptly posted the allergy alert.

During the monitoring inspection, it was observed that one classroom was out for a walk, while others were transitioning to the outdoor playground, engaging in free play, washing hands, eating lunch from their lunch boxes, and nap time.

The ratio was respected during the monitoring inspection.
