## **General Comments**

Name of operator

A renewal re-inspection occurred on August 8, 2025, as the facility was closed on July 22, 2025, when the Inspector arrived to conduct the renewal inspection on the license.

Upon arrival, Inspector observed the school-age children playing basketball outside and socializing with their peers.

Inside, Inspector observed morning snack, children engaged in board games, coloring, building in the construction zone, and dramatic play.

After lunch the children left for the park and scheduled swimming lessons.

Discussed with the Operator, Administrator and Educators during the inspection that Inclusion Support Workers are not counted in ratio, but he child/children they support are. When going to the pool, the Inclusion Support Worker is not counted in the reduced ratio of 1 educator to 8 school-age children if the child/children they support are in attendance. If the child/children are not in attendance, then the Inclusion Support Worker can be counted in ratio.

Discussed the posting of allergies and what is required for the parent board unless there is written permission from the parent/guardian to post the child/children's name.

Discussed with Administrator what is required to be posted on the parent board as per the Early Childhood Services Act and Regulations under the Act.

All staff and operator files were reviewed and verified complete. A random review of 15 children's files occurred and were ver
