<p>First Monitoring Inspection since licensing.</p> <p>Children and educators observed engaged in a variety of activities this morning including sensory play, outdoor play, stories, open ended art, and science experiments. Educators observed following the children's lead as they chose activities and materials.</p> <p>Each learning environment is set up with a variety of materials and invitations for the children to explore. Planning sheets are completed and support the children's current interests. QA Monitor discussed with staff adding photos, documentation and open-ended art pieces throughout environments.</p> <p>QA Monitor discussed choking hazards with staff working with children two and under. Ensure that small items are only used under direct supervision and kept out of reach of children when not in use.</p> <p>Some bins within the rooms are closed with covers. Materials to be open and accessible. QA Monitor discussed with administrator during inspection.</p> <p>A reminder to be sent to parents regarding medications. Staff must be given medications at arrival; medication is not permitted to be left in cubbies.</p> <p>Fire evacuation procedures and floor plans to be posted at each exit.</p>
