General Comments

Monitoring Inspection:

Children and educators observed engaged in a variety of activities this morning including stories, exploring vehicles, mark making with chalk, fine motor activities, building with blocks and outdoor play. A small group of children in the Two/Three Room were observed listening to an audiobook and following along with the hardcopy. Earlier in the morning they had been exploring vehicle tracks with paint to create a group art piece. The children and educators in the Three/Four Room were observed during quiet time; they were gathered around the table building with Mega Blocks and playing with a farm set as they engaged in meaningful conversations.

Purposeful planning is evident through documentation, invitations and materials added to the environments that support the children's current interests (cooking, vehicles, building, winter and hot cocoa). The dramatic play area within the Three/Fours has been turned into a "Hot Cocoa Shop" with a variety of materials set-up that invite children to engage in dramatic play.

QA Monitor recommends updating the labels on the bins in the Two/Three Room. This encourages children to tidy up independently and promotes literacy within the environment.

Nap time was observed today. The environments are dim, and educators put soft music on to ensure the environment is relaxing for children. The children's cots are set-up with bedding and are situated at an adequate distance apart. Educators observed comforting children as they settle in for nap.

Homemade chicken noodle soup with crackers, egg salad sandwiches and milk were served for lunch. Handwashing routines were observed during washroom routines and before mealtimes. Daily attendance records are accurate and reflect all children present. Child-to-staff ratio was observed to be met during Monitoring Inspection.

New staff file (5) review was completed, all required documents are in place.
